ERRORS ON ENTRIES-Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

THE CURRENT PRESIDENT, National Specialty Show Chairperson, Co-Show Chairperson and members of the Bench Show Committee, and members of their household, shall not exhibit, nor cause to be exhibited, dogs they own, or co-own, in competitive classes at this National Specialty Show The Agility/Obedience/Rally/Triathlon trial secretary and/or chairperson may exhibit, or cause to be exhibited, dogs they own, or co-own, in competitive classes at the National Specialty Show and affiliated events.

THE AFGHAN HOUND CLUB OF AMERICA RESERVES THE RIGHT TO TAKE CORRECTIVE ACTION against any individual(s) who engage in inappropriate conduct prejudicial to the interest of the sport of purebred dogs, or the Club, as determined by Club officials, and/or the Event Committee. Individuals who engage in disruptive or aggressive conduct at any event during the National Specialty will be subject to corrective action, including discipline and/or expulsion from the event. Should the Event Committee determine that expulsion is the appropriate course of action, refunds will not be given.

ALL RIGHTS TO TELEVISE, VIDEO TAPE, ADVERTISE, PHOTOGRAPH, PROMOTE or otherwise exploit this event are vested in the Afghan Hound Club of America, Inc., or in persons to who assignments of such rights have been made in writing by the Club. JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

DOGS PARTICIPATING- This trial is open to all Afghan Hounds over the age of 6 months that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP). Dogs must be physically sound. Dogs that are blind or deaf shall not be eligible. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Due to space limitations ONLY Dogs that are entered in the trial are permitted on show grounds.

BITCHES IN SEASON are not eligible to participate or be in the Trial Room before or during competition. Entry fees will be refunded. Notification for refund of entry fees for bitches in season must be provided to the Trial Secretary in writing at least 30 minutes prior to the start of the first class for the day.

Fix and Go On (FNG) As outlined in AKC Obedience Rules and Regulations Effective 2/29/2021, FNG allows the handler to choose to use a "Fix n' Go" option once, which allows the exhibitor to immediately reattempt a single individual exercise. This allows the team to reattempt that one exercise, and then leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix 'N Go is not preentered; rather, it occurs during the course of the run.
